**Call To Order:** Mayor Moore called the regular council meeting to order on January 10, 2023 at 6:30pm. Mayor Moore invited those with citizens' concerns or special comments for the honorary to sign the sign-in sheet to make their concerns and comments heard.

Pledge Of Allegiance: Mayor Moore

Approval of Agenda: Mayor Moore asked for a motion to approve the agenda for January 10, 2023 council meeting. Commissioner Wheeler made the motion to approve the agenda and Commissioner Bridgers seconded the motion. Motion passed 3-0.

Approval of Minutes: Mayor Moore asked for a motion to approve December 13, 2022 regular council meeting minutes. Commissioner Wheeler made the motion to approve the December 13, 2022 minutes and Commissioner Atkinson seconded the motion. Motioned passed unanimously.

Public Hearings/Comments: Mayor Moore read the instructions of the Public Hearings/Comments, and opened the floor for public comments.

- A. Dennis Knight spoke on behalf of how illegal dumping has slowed down on his vacant lot. He thanked Code Enforcement Public Works and Town Hall Staff for excelling at their job. He also mentions that he wished there could be a fee if you are caught for illegal dumping.
- B. Jody Whitley: Zoning Officer Lucas spoke on behalf of Mr. Whitley, who petitioned the Town for the rights to hunt on the Town property, which the Bissette and Bass Farm out. He has permission from the Bissette and the Bass family but needs approval from the Town. He wants to slow down the deer and rabbits from eating the crops on the farm. Commissioner Wheeler motioned to approve Mr. Whitley to continue hunting the land of the Bissette and Bass farms, which is the Town of Elm City property, until further notice. 2nd by Commissioner Bridgers. The Motion passed 4-0.

  Commissioner Bridgers. The Motion passed 4-0
- 2. Heritage Cemetery: Mr. Dennis Knight spoke on behalf of the Heritage Cemetery board on the request for the Town to take over the maintenance of the cemetery. Mr. Knight and the Board agreed until they hear from former Congressman G.K. Butterfield on the grant to table any decision. The Town Board spoke on the possibility of annexing that property into Town Limits in the future.
