Auditors have been on site twice working with Tundra towards our 2023 audit completion. Specifically for Beef/Cattle for Slaughter operations. LEASING AND/OR PURCHASE.

7-30-2024

Spoke with (unmentioned) person at the state regarding our Lead Service Line Grant currently underway in which Mike Tolson is handling. There is a closing cost of \$18, 840 which has caught the town by surprise. Per spokesperson, the Town is not eligible for reimbursement of the closing costs because these monies are EPA monies. It would be solely up to the town to decide on the "go ahead" to process paperwork so the Engineer could get his 15% "up front" costs in engineering fees, but we would be responsible for coming up with the \$18,840.

Southern Corrosion wants us to continue painting the outside of the water tower. They state that the painting is something that they routinely do every year at no cost to the town. AN invoice has come in at \$13,043.76. I have asked for a list of maintenance done from last year to present and have not received any maintenance report yet.
